COMMUNITY CHOICE POWER SUPPLY PROGRAM

The City of Lowell is announcing the new rates and term for its Community Choice Power Supply Program through its new electricity supplier, **First Point Power**. The City's new aggregation rates are fixed **for all rate classes for 36 months (December 2024 to December 2027)** as follows:

For comparison purposes, National Grid's Basic Service rates are fixed from August 1, 2024 through January 31, 2025 -- Residential at \$0.16055 per kWh and Commercial at \$0.14823 per kWh.

No action is required by individual consumers. All accounts currently enrolled in the City's Program will be switched to First Point as of the December 2024 meter reads. This change will be noted on the December 2024 bills and will be seen on the January 2025 bills. Basic Service rates change twice a year or more, depending on rate class. As a result, the aggregation rate may not always be lower than the Basic Service rate. The goal of the aggregation is to deliver savings over the life of the Program against National Grid Basic Service. However, future savings cannot be guaranteed.
