EGREMONT SELECTS NEW ELECTRICITY SUPPLIER AND LOCKS IN RATE FOR THREE YEARS

EGREMONT, MA – The Town of Egremont has signed a thirty-six month contract with a new supplier, First Point Power. Beginning with the January 2025 meter reads, the Egremont Community Choice Power Supply Program will have a new rate of \$0.13209 per kWh for a product that meets the Massachusetts Renewable Energy Requirement plus uses an additional 5% Massachusetts Class I Renewable Energy Certificates.

For Egremont residents and businesses who are enrolled in the Town's Program, the current rate of \$0.10908 per kWh will expire and the new rate of \$0.13209 per kWh will take effect with the January 2025 meter reads. This represents an increase of \$14 per month on the supply side of the bill given average usage of 600 kWh. However, this new rate is 17.6 percent lower than National Grid's Residential Basic Service rate of \$0.16029 per kWh. Residents can expect to see an average savings of \$17 per month for January 2025. National Grid's Residential Basic Service rate of \$0.16029 per kWh will change on February 1, 2025 and should be known in late-December.

"The Program's product offering allows residents and businesses to take positive steps to reduce their dependence on non-renewable energy," said Juliette Hass, Egremont Sustainability Coordinator. "Combining that with the ability to provide stable rates to our residents is a win for the community."

Egremont launched its electricity program in January 2017 in an effort to develop an energy program that would be stable and affordable. From inception through June 2024, the Program has saved residents and small businesses over \$1.6 million in electricity costs as compared to Basic Service.

It is important to note that <u>no action is required</u> by current participants. This change will be seen on the February 2025 bills. All accounts currently enrolled in the Program will see the new rate and First Point Power under the "Supply Services" section of their monthly bill.

The Egremont Community Choice Power Supply Program has no fees or charges. However, anyone switching from a contract with a third-party supplier may be subject to penalties or early termination fees charged by that supplier. Ratepayers should verify terms before switching.

Basic Service rates change twice a year or more, depending on rate class. As a result, the aggregation rate may not always be lower than the Basic Service rate. The goal of the aggregation is to deliver savings over the life of the program against National Grid's Basic Service. However, future savings cannot be guaranteed.
