CHESHIRE ENERGY PROGRAM ANNOUNCES NEW SUPPLIER AND LONG-TERM RATE STABILITY

CHESHIRE, MA – The Town of Cheshire has signed a thirty-six month contract with a new supplier, First Point Power. Beginning with the November 2025 meter reads, the Cheshire Community Choice Power Supply Program will have a new rate of \$0.13750 per kWh. The Program will also continue to offer an optional product that uses 100% Massachusetts Class I Renewable Energy Certificates (RECs), at a rate of \$0.16448 per kWh.

For Cheshire residents and businesses who are enrolled in the Town's Program, the current rate of \$0.15051 per kWh will expire with the November 2025 meter reads and the new rate of \$0.13750 per kWh will take effect. This represents a decrease of \$8 per month on the supply side of the bill given average usage of 600 kWh. This new rate is approximately 11 percent lower than National Grid's Residential Basic Service rate of \$0.15484 per kWh however, the rate is 2 percent higher than the Eversource Residential Basic Service rate of \$0.13493.

Cheshire launched its electricity program in May 2016 in an effort to develop an energy program that would be stable and affordable. From inception through March 2025, the Program has saved residents and small businesses over \$2.1 million in electricity costs as compared to Basic Service.

It is important to note that <u>no action is required</u> by current participants. This change will be seen on the December 2025 bills. All accounts currently enrolled in the Program will remain with their current product offering and see the new rate and First Point Power printed under the "Supply Services" section of their monthly bill.

The Cheshire Community Choice Power Supply Program has no fees or charges. However, anyone switching from a contract with a third-party supplier may be subject to penalties or early termination fees charged by that supplier. Ratepayers should verify terms before switching.

Basic Service rates change twice a year or more, depending on rate class. As a result, the aggregation rate may not always be lower than the Basic Service rate. The goal of the aggregation is to deliver savings over the life of the program against Basic Service. However, future savings cannot be guaranteed.
